Welcome to 2024. I am excited about ACMPE and cannot wait to see what the future holds for those of you pursuing advancement in the College this year.

Certificates, Board Certification and Fellowship through ACMPE is a fantastic way to confirm your expertise in the medical practice management industry. Not only do these recognitions affirm your professional competency, but they are recognized by

physicians, healthcare executives, industry professionals, and your peers.

Tennessee has a rich history of industry professionals who are committed to achieving their goals of being a Fellow, a Certified Medical Practice Executive or Certificate holder. In 2023, we had 6 individuals who earned Certificates, 58 who are pursuing Certification, 3 who achieved Certification, 9 individuals pursuing Fellowship, and 14 who achieved Fellowship, with the total Fellows in Tennessee at 67.

CONTINUING EDUCATION AND VOLUNTEER HOURS

The new cycle CE cycle will end on December 31, 2024. You will automatically be enrolled into the new three-year cycle after the current cycle has closed. Please make sure you complete these to maintain your credentials. For Fellows, you are required to earn six volunteer hours, of which three hours must be related to healthcare.


Offering ACMPE Credit for state educational programs?
